- 1. Minimum Age to buy a ticket is 18 years of age or older. The name written on the ticket must also be a person of at least 18 years of age.

- 5. Tickets may be purchased by cheque, VISA, MasterCard, Debit card and cash. The Lottery committee's liability is limited to the purchase price of the ticket. Cut off for online purchases and cheque purchases for the draw is December 1, 2025 at the Wetaskiwin Health Foundation office.
- 6. Ticket control and distribution will be provided by the Wetaskiwin Health Foundation.

- 11. Anyone wishing to cancel his or her ticket purchase and receive a full refund may do so, providing that the request is in writing and is received by December 1, 2025 one week prior to the draw. - 12. Ticket purchasers are **not** eligible for tax receipts under Revenues Canada rules.
- 13. Retail value of prize is \$6000.00 including GST.
- 14. All prizes are transferable
- 15. All winners have 90 days from the date of the draw to claim their prizes. If any prize remains unclaimed for 1 day more than 90 from the draw date, a request will be made to Alberta Gaming & Liquor Commission for a decision regarding the disbursement of the prize(s)
